# 4. Report of County Councillor for Lynher - Jim Gale:

EDF Renewables UK are developing plans for a proposed solar farm located between Callington and the villages of St Mellion and St Dominic.

The project, which is provisionally called the Dupath Spring Solar Farm, is for a 49.9 MW (80 hectare) Solar Farm on a 120 hectare site which straddles the A388.

The feed for it will be at Landulph substation with underground cabling. It could supply15K houses. The whole of this area will not be solar panels; some is set aside for biodiversity.

A  $\pounds$ 20K per annum subsidy is offered to the community.

The public consultation is on 15<sup>th</sup> July at St. Dominick Village Hall. All are encouraged to attend Experience of similar applications elsewhere in the county is that it is likely to be approved.

#### 5.3. Tamar to Moor CAP meeting report:

AS and RJ attended. Carl Hearne was re-elected as Chair and Andrew Parsons as Vice Chair. AS was appointed to the Highways Sub-Group and the Funding Panel. A new tranche of funding is available for highways, so the scheme to distribute to Parish and Town councils will be re-established soon.

#### 6.3. Neighbourhood Priority Statement Working Group:

The final draft of the NPS statement is complete and has been sent to Cornwall Council NDP department. The feedback indicates that there needs to be a demonstrably more thorough consultation as there were three responses to the recent survey. They advise that the survey should be re-opened and a public event should be held to promote responses.

The document is 90% complete. St. Mellion is still leading the field in producing an NPS.

The final draft to be ready for review at the September meeting.

## 6.4. Government Planning Consultation

The Government have indicated that the likely changes to the NPPF will:

- Reduce the scope of applications that can be determined by committees.
- Introduce a new category of medium developments (between 10 and 50 houses) instead of the current distinction between minor and major applications at 10 homes.
- This new category links across to proposed reduced requirements for biodiversity net gain on minor and (the new) medium category sites.
- There are further proposals around sanctions for developers that do not build out consented sites.
- Further changes to the National Planning Policy Framework are expected in the summer following the publication of national development management policies, which will potentially narrow its scope to focus more on rules and expectations around the preparation of local plans.
